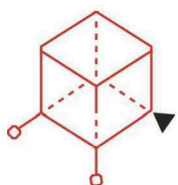

Recommendations on the use of information

contained in the Certificate of Deposit in the National Register of Intellectual Property for the protection of rights for the deposited file:

1. The intellectual property item is accessible to the owner of the deposited file 24/7 via the <https://nris.ru> website with a username/password for the site for a period of 2 years from the moment of its deposit (13-Apr-2022 16:30:49). Specifically, this file is available until 13-Apr-2024 16:30:49.
2. The Certificate serves as proof that the file remained unchanged during storage in the NRIS depository in the hash of the file, indicated on the front of the certificate. The hash was calculated upon deposit using the MD5 algorithm.
3. Viewing contents of the file is possible only when it is decoded using the author's key. The author's key can be downloaded at <https://nris.ru> after entering the login and password of the owner of the deposited cell. The file can also be assessed with a key duplicate held by the independent organizations listed above.
